# **ITQ Supplier Registration Instructions**

Thank you for showing interest in becoming an ITQ supplier. Below are the steps in completing ITQ Registration Process.

Before getting started, there are resources on our Supplier Service Center website that can assist with the process.

**Step 1: Apply for a six-digit Vendor Number.** Suppliers must apply for a six (6)-digit Commonwealth of PA Supplier Vendor Number. If you already have a vendor number, please proceed to Step 2. You will need your six (6) digit vendor number for Step 2.

## **PLEASE NOTE**

1. The Commonwealth of PA <u>REQUIRES</u> all suppliers to have an Employer Identification Number (EIN) issued by the IRS. If you do not have an EIN number, go to the IRS website <a href="https://www.irs.gov/businesses/small-businesses-self-employed/how-to-apply-for-an-ein">https://www.irs.gov/businesses/small-businesses-self-employed/how-to-apply-for-an-ein</a>.

Once you've obtained an EIN number, suppliers are must wait 7-10 business days to apply for a vendor number in the PA Supplier Portal;

2. You must use Internet Explorer and a non-apple product device to complete your registration; and

  - 1. **Service/Material Categories.** These are the commodity code(s) you will select, under the **Business Details** tab, during the registration process; and
